

Annual Report 2005 – 2006

During 2005/06, the Redwood City Education Foundation sustained our passion and our community's support by building on the amazing accomplishments of 2004/05 with even greater results in fund raising, parent participation, and program delivery. Thanks to the hard work of countless volunteers and the generous support of our many donors, we accomplished an impressive array of achievements:

- Raised a record \$270,000 through our annual SEED fund campaign, special events, and Gala event.
- Obtained \$81,000 in combined grants from Kaiser Permanente, the Westly Foundation, and the Cultural Commission of Redwood City.
- Increased parent participation by 13% ending the year with 15% of our parent households providing direct support.
- Funded new literacy, wellness, and teacher development programs.
- Launched a redesigned website with online donation capability, news and events announcements, and informative material on Redwood City schools and education in California.
- Launched a monthly eNews bulletin to communicate information about the RCEF and local education developments.
- Continued our outreach to the community with a screening and panel discussion of the PBS documentary First to Worst; town hall meetings with state and local representatives and education experts; and other presentations of interest to school families
- Created new mutually beneficial partnerships with local businesses and internet stores through our Merchants Program
- Expanded our volunteer corps to help with many tasks including writing, translating, special event assistance, graphic design, print production, and much, much more.

We believe these accomplishments are part of the reason our schools are strong and getting stronger. As test scores continue to climb at our schools, we are even more motivated to raise funds for the type of programs that will make our district exceptional.

Looking back at this past year, we are filled with gratitude for the local businesses, community members, teachers, and students who are our partners in excellence. Looking ahead, we know there are many challenges.

Our fundraising goal of \$300,000 is a demanding target. We are committed to expanding our programs to reach even more students. We hope to further increase parent participation. But looking ahead, we also know that we have the support of a talented and experienced board, creative and hard-working volunteers, and the people of Redwood City. We are ready for that brighter future, and we are prepared and ready for the work ahead.

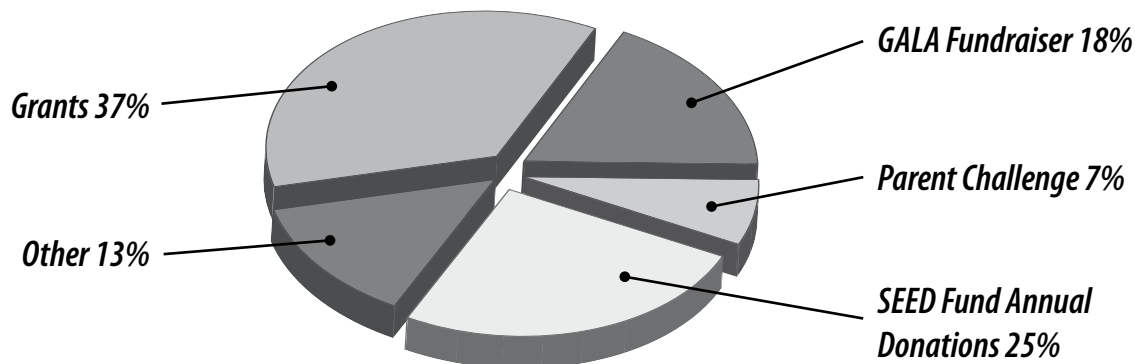

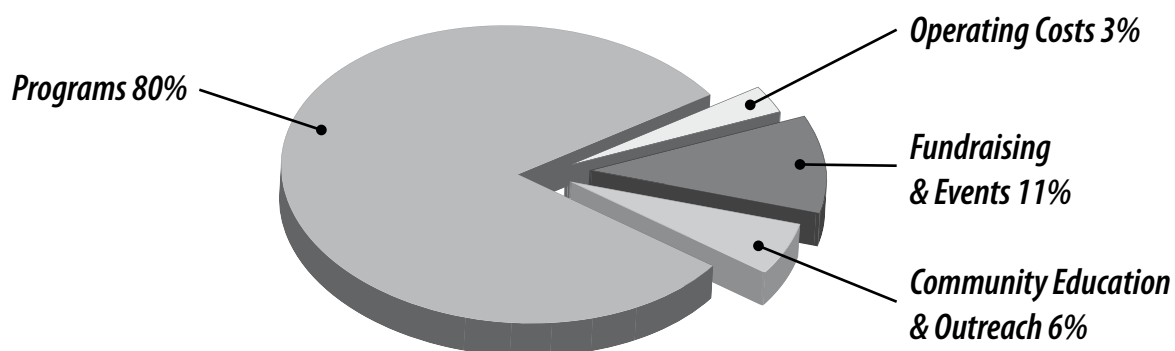
Financial Summary
